Emailed entry should include MIX IT UP" in Subject line & artist's name and contact information in message  
Entry must consist of at least 2 works and no more than 5 works of art (works may have to be emailed separately)  
Entry Deadline: June 3, 2010 by 5pm  
Accepted artists contacted by: June 4, 2010  
Accepted artists need to provide a typed artist statement on 8½" x 11" paper  
Drop off date for original art: June 8, 6 – 7:30pm (Artwork should have artist's name & contact info on the back)  
Works must be suitably framed, wired and ready to hang. Maximum size of work before framing 18" x 24"  
Exhibition Dates: June 10 – September 2  
Gallery Hours: Hours by appointment  
Artist Reception: Thursday, June 10, 6 – 7:30pm  
Show Closes: September 2  
Pick Up Art: September 7, 6:30 – 8pm

A 30% commission will be retained on all sales.

If work is accepted an information sheet will be emailed to you, to be completed and delivered with the original artwork on June 7.
